Serving over 900 students, the preliminary results are outstanding.

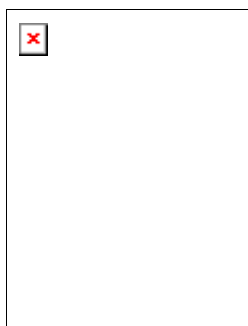
Busy Summer of Events!

From the Back of the House

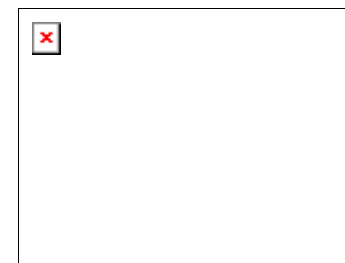

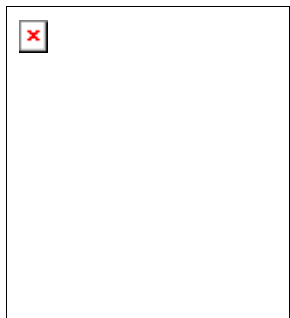

Through the generosity of our donors we were able to raise over **\$80,000** this year, which is essential to the well being of so many children. And to top it off, the Twins played a great game and won that night!

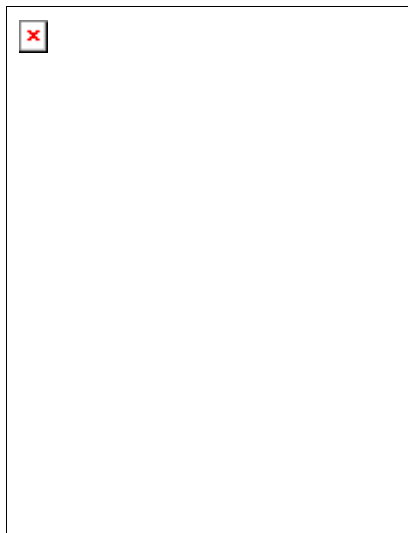

Family Support Services Program at CornerHouse

There are exciting updates at CornerHouse in our Family Liaison Program. The Family Liaison Program is now named the Family Support Services Program. This change came after many discussions about the importance and purpose of family support for the children who come to CornerHouse. Nancy Van Thorre's title has been changed to Family Support Coordinator. We felt that this title was more fitting in describing the work that Nancy does on a daily basis in helping families navigate resources, deal with immediate crisis intervention, and support their children past their CornerHouse interview.

More exciting news: CornerHouse was awarded a \$5,000 mini-grant from the Midwest Region: Children's Advocacy Center to improve our capacity to provide increasingly culturally competent services. We are using the funds to translate our Caregiver Booklet and other materials into multiple languages and to establish a Cultural Advisory Council to inform our interview and

Upcoming CornerHouse Child Sexual Abuse Forensic Interview Training Schedules

CornerHouse Interagency Child Abuse Evaluation and Training Center would like to announce the following availability in its 2011 training schedule.

Child Sexual Abuse Forensic Interview training at CornerHouse in Minneapolis, MN

This training teaches a credible, reliable and non-traumatic forensic interview process for children and vulnerable adults who allege sexual abuse. Training methods consist of lecture and discussion, review of CornerHouse videotaped interviews, skill-building exercises and an interview practicum. The course is designed for teams of law enforcement investigators, child protection investigators, prosecutors and forensic interviewers. Participants are strongly encouraged to attend as a multi-disciplinary team. Courses are outcome based and include an exam upon completion. Course Fee: \$950

CornerHouse Advanced Forensic Interview Training

This training is open to law enforcement, child protection investigators, prosecutors, and forensic interviewers who have completed the required prerequisites. This course teaches

advanced forensic interviewing issues, modifies the interview protocol for physical abuse and other violent crimes, outlines research on memory and suggestibility, provides a mock cross-examination demonstration, and provides participants the opportunity to learn and utilize a video-recorded interview assessment tool to critique their own interviews. Advanced training course at CornerHouse in Minneapolis, MN: Course Fee: \$850

1) Completion of one of the following basic interviewing courses:
