I've noticed that with the weather cooling a bit, many people are very cheerful. There is something about the cyclical nature of the seasons which bring about both excitement and energy for that which is coming in the new season, and almost a melancholy for that which has past.

We feel this in a particular way at CornerHouse. School re-opening means that with access and relationship to school liaison officers, children sometimes disclose abuse at school. It's fortunate that there are compassionate and trained officers at schools who can help get children who need to be interviewed to CornerHouse.

There's another cyclical event happening at CornerHouse: our board of directors and staff and community partners are now engaged in a strategic planning process. ### **"I ain't talking to no dude"**

Said the young girl as I greeted her in CornerHouse's waiting area as she covered her head and face with her hoodie, ran to her mother and buried her face in her mother's shoulder. To honor the wishes of that child, she was interviewed by one of our female forensic interviewers. As I approach the 100 interview mark as CornerHouse's only male forensic interviewer that has been the only time that a child has refused to talk to me because of my gender.

On other occasions, caregivers have expressed concern about their children talking to a male. In all of those cases, after meeting with the caregivers they decided that I should interview their child and all went well. A few times our referents have expressed the same concern, but at CornerHouse the child's feelings come first. If a child says that they do not want to be interviewed by a particular interviewer, we try to honor that child's wishes.

Studies show that the skill of the interviewer seems to matter more than gender. As adults, we have our own pre-conceived notions and biases which are not always the same as the child's. As a police detective, I investigated a case of teenage boy who reported being sexually abused by an adult female. CornerHouse had recently hired a male interviewer so I requested that he interview the child. The female interviewer learned that the child had no male figures in his life and was more comfortable talking to women. My pre-conceived notion was wrong. I learned a valuable lesson about listening to each child and paying attention to their needs.

## Upcoming CornerHouse Child Sexual Abuse Forensic Interview Training Schedules

CornerHouse Interagency Child Abuse Evaluation and Training Center would like to announce the following availability in its 2012 training schedule.

### **Child Sexual Abuse Forensic Interview training at CornerHouse in Minneapolis, MN**

This training teaches a credible, reliable and non-traumatic forensic interview process for children and vulnerable adults who allege sexual abuse. Training methods consist of lecture and discussion, review of CornerHouse videotaped interviews, skill-building exercises and an interview practicum. The course is designed for teams of law enforcement investigators, child protection investigators, prosecutors and forensic interviewers. Participants are strongly encouraged to attend as a multi-disciplinary team. Courses are outcome based and include an exam upon completion.

Course Fee: \$950

*November 5-9, 2012*

### **CornerHouse Advanced Forensic Interview Training**

This training course is for forensic interviewers, child protection workers, tribal social service investigators, law enforcement officers and prosecuting attorneys who have completed the required prerequisites. The course teaches advanced forensic interviewing skills including; modifications to the CornerHouse Forensic Interview Protocol: RATAAC® for physical abuse and other violent crimes, physical evidence in the forensic interview, autism spectrum disorders, multi-session forensic interviews, a mock cross examination demonstration and active participation in peer review using a variety of written assessment tools. Advanced training course at CornerHouse in Minneapolis, MN Course Fee: \$850

### **Prerequisites**

- 1) Completion of one of the following basic interviewing courses:
  - CornerHouse Child Sexual Abuse Forensic Interview Training or On-Site Child Sexual Abuse Forensic Interview Training
  - ChildFirst™
  - Finding Words™
  - First Witness™
- 2) Completion of a minimum of fifteen (15) interviews using RATAAC® (requirement waived for prosecutors)
