

Training Department in 2017

The CornerHouse Training Department had an extremely busy 2017! We completed 33 trainings, which is over 800 hours of content on forensic interviewing, mandated reporting and more. We trained 637 professionals from fields such as law enforcement, adult protection, and educators. Along with many trainings in Minneapolis, we traveled to 6 Minnesota counties and 7 different states around the country.



We developed a new training-- Vulnerable Adult Forensic Interview Training. This training teaches the CornerHouse Protocol with a focus on the unique needs of vulnerable adults. We are one of the only organizations in the county that offer training specifically for vulnerable adults, and we are excited to be responding quickly to the need for training in this area. Throughout the year we did four of these trainings, and hope to offer it several times next year.

We also had some amazing partnerships develop this year. We worked with the Nevada Department of Health and Human Services, Division of Child and Family Services to provide four On-site Basic Trainings in Nevada. Throughout these trainings, we were able to reach some remote areas of the state and train a wide variety of dedicated professionals.

We are working with the Minneapolis Institute of Art to create a comprehensive child safety policy and train employees in Mandated Reporting. The museum has thousands of children pass through the doors every year, and this is an important step in protecting children in Minneapolis.

Above all, we want to thank you! We appreciate your



dedication to receiving training and recommending our training to others. Confident professionals with the skills to handle difficult situations help end abuse. This benefits the entire community and generations of vulnerable children and adolescents. Again, thank you for working to end abuse.
