

# CornerHouse 2019 Fee Schedule



## **Basic Forensic Interview Training: (4.5 Days + 6 Hours Online Content)**

\$1,275 per-person tuition (within 30 days, registration is \$1,400). Four-and-a-half-day training conducted in-person. Six hours of online learning to be completed prior to in-person training. Light breakfast provided daily; lunch provided on Monday and Thursday. Attendees are responsible for all other meals, travel, and lodging.

## **On-site Basic Forensic Interview Training: (3.5 Days + 4 Hours Online Content)**

\$8,000 flat-rate tuition for up to 30 participants. Three-and-a-half-day training conducted at your site. Four hours of online learning to be completed prior to in-person training. The host site is responsible for the CornerHouse trainer's travel, lodging, and meal expenses, as well as providing break refreshments for trainees.

## **Vulnerable Adult Forensic Interview Training: (3.5 Days + 4 Hours Online Content)**

\$1,100 per-person tuition (within 30 days, registration is \$1,225). Three-and-a-half-day training conducted in-person. Four hours of online learning to be completed prior to in-person training. Light breakfast provided daily; lunch provided on Monday. Attendees are responsible for all other meals, travel, and lodging.

## **On-site Vulnerable Adult Forensic Interview Training: (3.5 Days + 4 Hours Online Content)**

\$8,000 flat-rate tuition for up to 30 participants. Three-and-a-half-day training conducted at your site. Four hours of online learning to be completed prior to in-person training. The host site is responsible for the CornerHouse trainer's travel, lodging, and meal expenses, as well as providing break refreshments for trainees.

## **Advanced Forensic Interview Training: (3 Days + 8 Hours Online Content)**

\$1,050 per-person tuition (within 30 days, registration is \$1,175). Three day training conducted in-person. Eight hours of online learning to be completed prior to in-person training. Light breakfast and lunch provided daily. Attendees are responsible for all other meals, travel, and lodging.

## **On-site Advanced Forensic Interview Training: (3 Days + 8 Hours Online Content)**

\$8,000 flat-rate tuition for up to 30 participants. Three-day training conducted at your site. Eight hours of online learning to be completed prior to in-person training. The host site is responsible for the CornerHouse trainer's travel, lodging, and meal expenses, as well as providing break refreshments for trainees.

## **Collecting Minimal Facts Training: (3 Hours In-person + 1 Hour Online)**

\$125 per-person tuition (within 30 days, registration is \$150). Three-hour training conducted in-person. One hour of online learning to be completed prior to in-person training. Light breakfast provided. Attendees are responsible for all other meals, travel, and lodging.

## **On-site Collecting Minimal Facts Training: (3 Hours In-person + 1 Hour Online)**

\$900 flat-rate tuition for up to 30 participants. Three-hour training conducted at your site. One hour of online learning to be completed prior to in-person training. The host site is responsible for the CornerHouse trainer's travel, lodging, and meal expenses, as well as break refreshments for trainees.

## **CornerHouse MultiSession Interview™ Training: (2 Days)**

\$600 per-person tuition (within 30 days, registration is \$650). Two-day training. Light breakfast provided daily. Attendees are responsible for all other meals, travel, and lodging.

## **On-site CornerHouse MultiSession Interview™ Training: (2 Days)**

\$4,500 flat-rate tuition for up to 30 participants. Two-day training conducted at your site. The host site is responsible for the CornerHouse trainer's travel, lodging, and meal expenses, as well as break refreshments for trainees.

## **Customized Training:**

CornerHouse offers specialized training sessions to meet the unique needs of specific audiences on a variety of topics. Fees are determined on a case-by-case basis. For requests requiring one CornerHouse trainer and training material development, a fee of \$3,000 per day (up to eight hours) or \$375 per hour is standard. An additional travel fee of up to \$150 per travel hour may be charged for hourly training. The host site is responsible for the CornerHouse trainer's travel, lodging, and meal expenses.

## **Consultation Services:**

CornerHouse is available to work with your agency, team, or developing program to best meet your needs. Consultation services are available on a variety of topics, including but not limited to program development, multidisciplinary team development, peer review, creating a person-centered environment, board development, family services programming, and adult learning. Consultation services are \$150 per hour.

## **International Travel Fee:**

CornerHouse charges an additional \$250-\$1,000 rate for trainer's roundtrip international travel time.
