CASE STORY

T stated several times during her child’s forensic interview that she had no idea “the people would be so nice and supportive” here. During a follow-up call last week, T stated that shortly after the interview, she and her child went on a vacation, and she heard her child’s giggle for the first time in months. T is now looking into therapy options, as her child told her after the interview that “talking made me lighter.”

CornerHouse Home Visiting Program Helps Support Families in our Community

The CornerHouse Home Visiting Program provides targeted families with intensive support, parent education, and referral services to promote safe, healthy, and stable environments for their children.

When caregivers bring their children to CornerHouse for an interview because of a concern that someone has abused their child, they are often experiencing a number of stressors, such as homelessness, isolation, limited English skills, or domestic violence, that make accessing trauma-informed services difficult. Providing services in the home or community allows the qualified families we serve to access trauma-informed support that would not otherwise be accessible.

The CornerHouse Home Visiting Program is offered in English and Spanish and includes weekly visits focusing on building the six protective factors that promote the health and well-being of children in the presence of stress.

The six protective factors include:

1. Nurturing and Attachment
2. Concrete Supports for Parents
3. Parent Resiliency
4. Knowledge of Parenting and Child Development
5. Social and Emotional Well-Being of the Child
6. Social Connections

CornerHouse has served a total of ten families through the Home Visiting Program thus far in 2014. The Family Services Director has worked with these families to gain access to basic needs and medical and mental health resources.

These families received an entire household of furniture and other household goods. This fund has also helped a family, who was living out of their car, secure stable housing. Helping families build concrete supports allows them to create a safe and stable environment for their children where healing can take place.
