FORENSIC SERVICES- THE FORENSIC SERVICES OF CORNERHOUSE PROVIDE A PERSON-CENTERED APPROACH TO FACT FINDING AND GATHERING OF INFORMATION IN CASES WHERE THERE IS REASON TO BELIEVE THAT SEXUAL OR PHYSICAL ABUSE HAS OCCURRED OR IN CASES WHERE CHILDREN, ADOLESCENTS OR VULNERABLE ADULTS HAVE WITNESSED A VIOLENT CRIME. IN THE YEAR 2014, MORE THAN 450 INDIVIDUALS WERE INTERVIEWED. THE GOAL IS TO PROVIDE AN INTERVIEW WHICH IS FAIR, LEGALLY SOUND AND NEUTRAL. INTERVIEWS ARE CONDUCTED WITH CHILDREN FROM 2 YEARS, 9 MONTHS, TO ADOLESCENTS AND VULNERABLE ADULTS. THE CORE PHILOSOPHY OF THE CORNERHOUSE WORK IS THAT OF "PERSON-CENTERED". THE INTERVIEW PROCESS, THE DECOR AND PHYSICAL LAYOUT OF THE HOUSE AND THE SUPPORT SERVICES OFFERED INCORPORATE THE COMMITMENT THAT THE INDIVIDUAL'S -- CONTINUED ON SCHEDULE O --

TRAINING- CORNERHOUSE IS AN INTERNATIONAL LEADER IN TRAINING PROSECUTORS, LAW ENFORCEMENT AND CHILD PROTECTION WORKERS IN FORENSIC INTERVIEWING. BECAUSE OF OUR LEADERSHIP IN THE DEVELOPMENT OF A FORENSIC INTERVIEWING PROTOCOL ALMOST 25 YEARS AGO, CORNERHOUSE WAS SOUGHT AFTER TO DEVELOP THE TRAINING ON THE PROTOCOL. UTILIZING THE EXPERIENCED FORENSIC INTERVIEWERS ON STAFF AS TRAINERS IN THE PROGRAM, CORNERHOUSE CONDUCTS TRAINING FOR BOTH BASIC AND ADVANCED LEVELS OF LEARNING. TO DATE, CORNERHOUSE HAS TRAINED OVER 30,000 CHILD ABUSE PROFESSIONALS IN 50 STATES AND 19 FOREIGN COUNTRIES INCLUDING AMERICAN SAMOA, CANADA, COLOMBIA, IRELAND, JAMAICA, JAPAN, KOSOVO, NIGERIA, URUGUAY AND THE INTERNATIONAL COURT OF THE HAGUE. IN 2014, TRAINING OCCURRED IN JAPAN AND IN TRINIDAD.

FAMILY SERVICES- THE CORNERHOUSE FAMILY SERVICES ARE DESIGNED BASED ON RESEARCH, WHICH REFLECTS THAT CHILDREN AND ADOLESCENTS ARE MORE LIKELY TO BE KEPT SAFE IF THEIR FAMILY/CAREGIVERS FEEL SUPPORTED. CORNERHOUSE WORKS TO ASSURE THAT THE LIKELIHOOD OF RE-VICTIMIZATION IS MINIMIZED BY HELPING TO PROVIDE THIS SUPPORT. DURING THE INTERVIEW, CAREGIVERS MEET WITH A PROFESSIONAL COUNSELOR WHO ADDRESSES SUCH ISSUES AS CRISIS MANAGEMENT, PLANNING FOR THE SAFETY OF THE CHILD AND REFERRAL FOR COUNSELING. IN 2014, OVER 80% OF THE FAMILY MEMBERS RECEIVED A CONSULTATION FROM THE CORNERHOUSE FAMILY SERVICES STAFF. ALSO DURING 2014, A HOME VISITING PROGRAM WAS BEGUN IN WHICH FAMILY SERVICES STAFF GO TO THE HOME AND ASSIST WITH ONGOING SUPPORT, COUNSELING AND PARENTING SKILL DEVELOPMENT.
