



# CornerHouse Position Announcement

## Family Services Therapist Part Time

**CornerHouse assures that the voices of children and adolescents are heard.** CornerHouse conducts forensic interviews and medical exams for individuals who report abuse, supports individuals and families for best outcomes, and provides training to investigative professionals.

**Position Summary:** The Family Services Therapist works with families and individuals referred to CornerHouse offering person-centered, trauma-informed, holistic therapy services. The Family Services Therapist works as a part of a multidisciplinary team that provides alleged victims of abuse/witnesses to violent crime, and their caregivers, services that are attuned to the complex needs of traumatized clients. The Family Services Therapist provides direct crisis intervention, information, and referral services to families and community members, as well as psychotherapy to enhance the capacity of caregivers to support their child's needs, and direct therapy to children affected by trauma. The Family Services Therapist additionally provides community education and outreach, and works collaboratively with partners to assess and meet the stated needs of the CornerHouse service population.

### **Position Responsibilities:**

#### **1. Provide person-centered, trauma-informed, holistic victim/survivor/witness support and advocacy to families referred to CornerHouse for a Forensic Interview.**

- a. Offer a person-centered, welcoming, and supportive environment attuned to each family and individual's particular needs.
- b. Effectively intervene in crisis situations to ensure open communication, choice, and a safer environment for families and staff.
- c. Provide Interview Accompaniment, Crisis Intervention, and Support to Caregivers.
  - i. When requested by Forensic Services, call the family and offer information to support them in preparing for and attending the forensic interview.
  - ii. Offer crisis intervention and support during the program participants' forensic interviews.
  - iii. Assist in the identification of individual and family needs.
  - iv. Facilitate access to needed therapeutic, medical, and community resources ranging from basic economic needs to more complex mental health needs.
  - v. Connect to appropriate resources on matters pertaining to crime victim compensation, court procedures, and the criminal justice system.
  - vi. Provide educational information regarding the dynamics and effects of sexual abuse or witnessing violence.
  - vii. Conduct risk assessment and safety planning as needed.
  - viii. Make referrals to victim/witness services as needed and coordinate with the Hennepin County Victim Witness program.
  - ix. Offer family services (support group, home visiting, case management) at CornerHouse and gauge family interest and need.
  - x. Work with multi-disciplinary team members to share information regarding presenting strengths and concerns when sharing such information is relevant to the immediate needs of the family and/or the investigation.
  - xi. Provide a follow-up support call to families to ensure connection to resources, to advocate with families within the criminal justice and child protection systems, and to promote continued engagement with the Family Services program as needed.
- d. Provide In-Home Psychotherapy through the Home Visiting Program.
  - i. Provide thorough person-centered, trauma-informed diagnostic assessment to families interested in Home Visiting to ensure fit of services for family's needs.
  - ii. Meet with caregivers weekly for 4 to 6 months in their home providing intensive therapy services to increase caregiver resiliency through completing the curriculum for home visiting with the family.
  - iii. Complete required measures to evaluate family's growth and the home visiting program.
- e. Provide Outpatient Psychotherapy services.
  - i. Provide thorough person-centered, trauma-informed diagnostic assessment to clients to ensure fit of services for family/individual's needs.
  - ii. Create a treatment plan for clients to work towards treatment goals for the individual or

- family's healing and growth.
- iii. Learn and practice trauma therapy interventions, focusing on those for youth ages 4-17.
  - iv. Conduct regular review of treatment plan and service provision, closing case when client is no longer in need of, or requesting, outpatient therapy services.
- f. Provide Caregiver and Child Support Group program three times per year.
- i. Partner with a therapy provider who will facilitate the Children's Support Group.
  - ii. Offer a person-centered, welcoming, and supportive group environment to promote engagement, hope, and healing amongst group members.
  - iii. Continue to enhance the group curriculum through ongoing revision and integration of new topics reflective of the needs of the program and group.
  - iv. Conduct outreach and marketing of support groups to CornerHouse staff, MDT and community partners, and community members.

### Qualifications:

- Masters degree required in social work or related profession with related licensure (LICSW, LGSW, LPC, LPCC, LP, LMFT, LAMFT)
- Knowledge of multi-cultural practice, child sexual abuse, family dynamics, child development, investigative and/or judicial systems
- Demonstrated experience in the following areas preferred:
  - Working with culturally, ethnically, developmentally, and socio-economically diverse individuals;
  - Working with crime victims and/or persons in crisis; and
  - Working with child protection, law enforcement, court systems and related community services
- Strong communication, organizational, and problem solving skills
- Team player, self-starter
- Computer proficiency, including Word, Excel, and PowerPoint; ability to learn and utilize database systems.
